1.2 NVOCC / CONSOLIDATOR

NVOCC means Non-Vessel Operating Common Carrier. NVOCC books large quantity of space with ship and sells space to shippers in smaller amounts. NVOCC consolidate small shipments of LCL (less container load) and issues HBL (House Bill of Lading). NVOCC also undertake the services provided by a freight forwarder. A freight forwarder is not typically a carrier buy act as a 'carrier 'legally as per Multi Model Transport Document Act. He is an expert in Supply chain management. A freight forwarder books large number of containers and sells to shippers with lesser rate. Each freight forwarder has their overseas counterpart to handle each shipment. This helps the shipper and consignee for smooth handling of cargo compared to the service of direct shipping carriers. A freight forwarder also under take inland movements, arrange insurance on behalf clients, undertake the activities of customs clearance etc. In short, a freight forwarder undertakes all business activities between a buyer and seller.

1.3 SHIP CHARTERING & SHIP BROKER

A cargo owner needs cargo moved (or a ship operator needs an additional ship.)

- ✤ He engages a shipbroker who finds suitable ships.
- After meticulous checking of the ships, the charterer chooses a ship, and via the broker, makes a FIRST OFFER.

- The shipowner either accepts or rejects the offer.
- Further offers and counter-offers may lead to a charter being FIXED, i.e. the shipowner and the charterer agree to the charter, and a CHARTER PARTY (a special document) is signed by the owner and the charterer. All details in the charter party govern the charter.



Similarly, a shipowner may engage the services of a shipbroker to find cargo for his ship. The procedure is the same as outlined above.

MEASURES TAKEN DURING SHIPBOARD OPERATION FOR THE SAFETY OF SHIP'S CREW, CARGO AND MARINE ENVIRONMENT

In every shipboard operation, the three prime factors that should be focused on by the onboard personnel are – safety of the crew, safety of the ship and cargo, and protection of marine environment.

The ship's crew should always remember that whatever they do, the bottom line in all circumstances must be – 'Safety First'.

During cargo operation in a Container Ship, following points are to be remembered to ensure safety of the crew, cargo, and marine environment:

- When it comes to the crew, personal Protective Equipment must be worn during cargo operation which includes the safety shoes, safety helmet, overall, gloves, etc.
- While handling the ongoing cargo operation, be careful not to come in the way or stand under any heavy load.
- **4** Safety of the cargo involves the correct lashing and securing of the cargo.
- Safety of the personnel involves correct lashing procedures to avoid back injuries and sprains.
- Onboard refrigerated cargo is to be monitored and should be maintained at their required temperatures.
- Dangerous goods of different categories have to be packaged and segregated as per the IMDG code.
- No source of ignition should be allowed into or near to a place where dangerous goods containers or IMDG containers are stowed.



- The lashing bridge and catwalks must be in a safe condition to work.
- All the lashing bars and lashing equipments must be in place and not left lying on the lashing bridge floor.
- One must never stand or walk under a working spreader. The consequences could be fatal if an accident occurs.
- Mooring ropes of the ship should be kept tight all the time.
- Safety signs should be posted at appropriate places. (For example 'No Smoking' signs).
- Security level to be displayed and ISPS duties to be performed properly.
- The deck and even the cargo holds should be free of oil or greasy material. If the deck is found in such a condition it must be cleaned up immediately.
- Cargo holds containing dangerous cargo or fumigated containers should be well ventilated. Entry into such a hold with inadequate ventilation must not be allowed.



- Dangerous cargoes must be stowed on deck or in the holds as per the Ship's stowage plan for dangerous cargoes and should be well away from living quarters.
- Any kind of oil spill or leak must be prevented so as to avoid pollution of the seas.
- When an incident takes place involving the loss or likely loss overboard of packaged dangerous goods into the sea, the Master shall report the particulars of such an incident without delay to the nearest coastal State.
- The report shall be based on the Supplement to the IMDG-Code "Reporting Procedures". When the ship is within or near an area for which a ship reporting system has been established, reports shall be transmitted to the designated shore station of that system.
- **4** Emergency exits and escape routes must be clear of all obstructions at all time.
- All crew should be aware of the dangerous cargo spill contingency plan which is kept in the deck office
- **4** First aid kit and defibrillator must always be present in the deck office.

International concern arising from various outstanding sea disasters : including the Valdez Alaska accident and the airplane crash on the aircraft carrier the USS Nimitz in 1981, resulting in sea pollution and loss of life, forced a series of actions to be taken by national–international organizations and governments to reduce the incidence of sea accidents.

There was also concern in the international shipping community. The prestige and the image of shipping was at stake for onboard substance abuse resulting in accidents and sea pollution. Drastic action was necessary and the decision was to implement a drug/alcohol policy. The organizations concerned with promoting the safety and health of mariners provided relevant information /regulations for implementing drug/alcohol policies.

Maritime diligence and safety became a top priority with emphasis placed on the "human element". The mariner was therefore called upon, not only to protect himself, but also his livelihood, the ship. According to IMO, over 80% of marine accidents are caused by human error.
